AFFIDAVIT

I, Karen Osborne, being first duly sworn upon my oath depose and state the following:

1. I am the Maricopa County Director of Elections and have been employed by Maricopa County as its Director since 1994 and the Deputy Director of Elections since 1991. I also serve as a Deputy to Maricopa County Recorder Helen Purcell. I am responsible for the process of registering eligible persons to vote and polling place procedures, including proof of identification at the polls, in Maricopa County, and therefore have knowledge relevant to the matters described herein.

2. Prior to Proposition 200, there was no mechanism to verify a registrant's citizenship. As a result, individuals who were not U.S. citizens registered to vote although they were ineligible to do so.

3. Since August 2003 the U.S. Citizenship and Immigration Services (USCIS) has requested information from the County regarding voter registration

1 and voting history of individuals that has applied to become naturalized citizens.
2 A list of individuals about whom the U.S. Citizenship and Immigration Services
3 (USCIS) requested information regarding voter registration and voting history
4 was kept in the regular course and scope of the Department's operations. There
5 have been 100 requests. Of those 100 individuals, 74 of the individuals were
6 registered to vote and 25 had voted in an election. That list is attached hereto as
7 Exhibit A and incorporated herein by reference.

8 4. In 2007, the Elections Department maintained lists of individuals
9 whose voter registrations were cancelled upon notification from the jury
10 commissioner that the individual stated on a jury questionnaire that he or she
11 was not a United States citizen. Those lists, which also indicate the person's
12 voting history, were kept in the regular course and scope of the Department's
13 operations. Such lists, dated 2/22/07, 3/30/07, 8/31/07, and 12/07/07, are
14 attached hereto as Exhibit B and incorporated herein by reference.

15 5. In 2007, the Elections Department maintained lists of individuals
16 whose voter registrations were cancelled upon notification from the jury
17 commissioner that the individual stated on the jury questionnaire that he or she
18 was a convicted felon who had not had his or her civil rights restored. Those
19 lists, which also indicate the person's voting history, were kept in the regular
20 course and scope of the Department's operations. Such lists, dated 5/01/07,
21 9/25/07, and 10/10/07, are attached hereto as Exhibit C and incorporated herein
22 by reference.

1 6. When voter registration organizations submit batches of completed
2 voter registration forms, the Elections Department will identify the name of the
3 organization and track the forms submitted by that organization. For one voter
4 registration organization, Petition Partners, the Department documented the
5 number of voter registration forms submitted and the rate of acceptability of the
6 registrations. The list dated 10/16/07, which was kept in the regular course and
7 scope of the Department's operations, provides the number of registration forms
8 submitted, the rate of acceptability, the date the Department received the
9 registrations, and the person submitting the forms. That list attached hereto as
10 Exhibit D and incorporated herein by reference.

11 7. From September 2005 through September 2007, Petition Partners
12 submitted 27,745 voter registration forms, of which only 6,706, or 24%, were
13 acceptable to add to the voter registration rolls. During a two year period, the
14 Department either rejected or placed on suspense 21,039 voter registration
15 forms that had been submitted by that one organization.

16 8. Maintaining a current and accurate voter roll is a constant challenge
17 for election officials due to voters moving without updating their voter registration,
18 a voter's death, or a voter becoming ineligible to vote based on a criminal
19 conviction. The Elections Department spends considerable time and resources
20 maintaining a current and accurate voter registration database.

21 9. By enacting the voter identification law, the State is able to safe-
22 guard against persons who may vote using the name of non-existent voters that

1 may have been added to the voter registration database prior to the proof of
2 citizenship requirement. The voter identification requirement provides the
3 assurance that the person voting is in fact the same eligible person who is
4 registered on the voter rolls.
