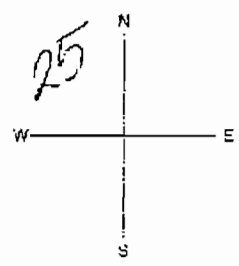



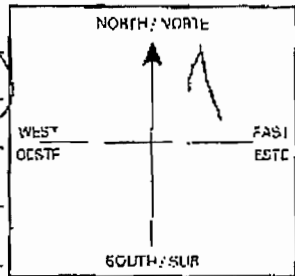

Nina- Ms. Krysty Marin, Yuma County's Voter Registration Coordinator, has provided the following response to your inquiry:

We did not track rejections prior to going onto our new system January 24, 2007. Our old computer system had no way to track rejected registrations and was not a state requirement therefore I did not track them. The new statewide voter registration system does have a place to enter if the voter was rejected and for what reason.

The only reason why we had our rejected registrations set aside and not filed away with all the other files is because when we went onto this new statewide system we really weren't sure how everything worked. Entering the status of the registration (suspense, rejected, pending) was new for us, our old system didn't have a way to enter them. It was easier for us to have the files set aside so we could monitor the new statewide system to make sure how it was working before we filed them away. In the meantime this lawsuit requested our records and we just happened to have those registrations set aside.
