1 Defendants Yuma County Recorder Susan Hightower Marler and Yuma
2 County Elections Director Patti Madrill (Yuma County), by and through
3 undersigned counsel, hereby submit the following Responses to Gonzalez
4 Plaintiffs' Second Set of Requests for Production of Documents to County
5 Defendants.

6 GENERAL OBJECTIONS

7 The following objections are applicable to and incorporated into each
8 answer.

- 9 1. Defendant objects to each Interrogatory served by Plaintiff in this
10 action to the extent that it is overbroad, burdensome, oppressive,
11 vague, or generally unspecific as to what a complete answer is.
- 12 2. Defendant asserts these objections without waiving or intending to
13 waive any objections as to competence, relevance, materiality,
14 conclusion of law or privilege.

15 REQUESTED ITEMS

16
17 **Request for Production No. 1:** Provide all documents related to rejected voter
18 registration applications, including, but not limited to, rejected voter registration
19 application forms, correspondence with unsuccessful voter registration
20 applicants, log books and tallies, from the date January 24, 2005 to the present.
21 (This RFP only applies to those documents not already produced to ITCA
22 Plaintiffs before 12/01/07).

1 **Response:** Rejected voter registration forms from Defendants not
2 produced previously are enclosed.

3 **Request for Production No. 2:** Provide all documents related to efforts to
4 educate or inform the public that an "Alien Registration Number" can be
5 provided by a voter registration application as acceptable proof of citizenship for
6 voter registration in Arizona pursuant to Proposition 200.

7 **Response:** The documents requested do not exist.

8 **Request for Production No. 3:** Provide all documents related to whether you
9 have taken the position that a person may submit a photocopy of his United
10 States Certificate of Naturalization to satisfy the proof of citizenship
11 requirements of Proposition 200 and the efforts you have taken to educate or
12 inform the public of this position.

13 **Response:** The documents requested do not exist.

14 **Request for Production No. 4:** Provide all documents related to efforts to
15 educate or inform the public that making photocopies of one's United States
16 Certificate of Naturalization is legal, or not illegal.

17 **Response:** The documents requested do not exist.

18 **Request for Production No. 5:** Provide all documents related to any
19 investigation into whether, or any determination that, making a copy of a
20 Certificate of Naturalization is legal, or not illegal.

21 **Response:** The documents requested do not exist.

22 **Request for Production No. 6:** Documents showing, by month: the number of

1 voter registration applications received by the County Recorder's office; the
2 number of voter registration applications rejected for failure to provide proof of
3 citizenship pursuant to Proposition 200; the number of voter registration
4 applications rejected for reasons other than failure to provide proof of citizenship
5 pursuant to Proposition 200; the number of successful voter registration
6 applications (i.e. that resulted, without further supplementation, in the applicant
7 being added to the voter rolls), for the period July 1, 2004 to December 1, 2007
8 (applies to documents not already produced to ITCA Plaintiffs before 12/01/07).

9 **Response:** The documents requested do not exist.

10 **Request for Production No. 7:** Provide all documents showing the names and
11 addresses of voter registration applicants whose applications were rejected for
12 reasons other than failure to provide proof of citizenship pursuant to Proposition
13 200, by month, since January 1, 2005.

14 **Response:** The documents requested do not exist. All voter registration
15 forms that have been rejected for any reason have been produced. See
16 Response to Request for Production Number 1.

17 **Request for Production No. 8:** Provide all documents related to fraud
18 involving military personnel registering to vote using the federal post card
19 application.

20 **Response:** Defendants object to this Request to the extent that it is
21 overbroad, unduly burdensome, vague and ambiguous, documentation does not
22 exist, or has already been produced.

1 **Request for Production No. 9:** Provide all documents related to fraud
2 involving the submission of federal mail voter registration forms.

3 **Response:** Defendants object to this Request to the extent that it is
4 overbroad, unduly burdensome, vague and ambiguous, documentation does not
5 exist, or has already been produced.

6 **Request for Production No. 10:** Produce all documents related to complaints
7 made by; or reports of problems experienced by, individuals registering to vote
8 or voting from January 1, 2000 to the present.

9 **Response:** Defendants object to this Request to the extent that it is
10 overbroad, unduly burdensome, vague and ambiguous, documentation does not
11 exist, or has already been produced.

12 **Request for Production No. 11:** Produce all documents related to
13 communications between the county and voter registration organizations,
14 including, but not limited to, communications between the county and political
15 parties, nonprofit organizations and private companies conducting voter
16 registration, since January 1, 2004.

17 **Response:** Defendants object to this Request to the extent that it is
18 overbroad, unduly burdensome, vague and ambiguous, documentation does not
19 exist, or has already been produced.

20 **Request for Production No. 12:** Produce all documents showing the amount
21 and purpose of federal funds received by the county for election and voter
22 registration related activities since January 1, 2004.

1 **Response:** Defendants object to this Request to the extent that it is
2 overbroad, unduly burdensome, vague and ambiguous, documentation does not
3 exist, or has already been produced. Without waiving any objection, Defendants
4 do not have the documentation requested because Defendants do not receive
5 funds directly from the federal government for election or voter registration
6 activity.

7 **Request for Production No. 13:** Produce all documents related to any history
8 of official discrimination that touches the right of any Latino to register, to vote,
9 or otherwise to participate in the democratic process.

10 **Response:** Defendants object to this Request to the extent that it is
11 premised on a legal conclusion, overbroad, vague and ambiguous.

12 **Request for Production No. 14:** Produce all documents related to any racially
13 polarized voting in the County.

14 **Response:** Defendants object to this Request to the extent that it is
15 premised on a legal conclusion, overbroad, vague and ambiguous.

16 **Request for Production No. 15:** Produce all documents related to unusually
17 large election district, majority vote requirements, anti-single shot provisions, or
18 other voting practices or procedures that may enhance the opportunity for
19 discrimination against Latinos.

20 **Response:** Defendants object to this Request to the extent that it is
21 premised on a legal conclusion, overbroad, vague and ambiguous.

22 **Request for Production No. 16:** Produce all documents related to any

1 candidate slating in the County, or any political subdivision thereof.

2 **Response:** Defendants object to this Request to the extent that it is
3 premised on a legal conclusion, overbroad, vague and ambiguous.

4 **Request for Production No. 17:** Produce all documents related to the
5 discrimination against Latinos in such areas as education, employment and
6 health, which hinder their ability to participate effectively in the political process.

7 **Response:** Defendants object to this Request to the extent that it is
8 premised on a legal conclusion, overbroad, vague and ambiguous.

9 **Request for Production No. 18:** Produce all documents related to overt racial
10 appeals with regard to Latinos in political campaigns in the County.

11 **Response:** Defendants object to this Request to the extent that it is
12 premised on a legal conclusion, overbroad, vague and ambiguous.

13 **Request for Production No. 19:** Produce all documents which indicate each
14 and every Latino/Hispanic that has been elected to public office in the County, or
15 any political subdivision thereof, including the title of the office, the jurisdiction of
16 such office, and the date of such election.

17 **Response:** Defendants object to this Request to the extent that it is
18 premised on a legal conclusion, overbroad, vague and ambiguous. Without
19 waiving any objection, documentation regarding election results was produced
20 In Defendant's Response to Gonzalez Plaintiffs' First Request For Production Of
21 Documents, Response Number 12.

22 **Request for Production No. 20:** Produce all documents related to whether

1 Latinos are less likely to possess the forms of identification required under
2 Proposition 200 to register to vote and cast a ballot.

3 **Response:** Defendants object to this Request to the extent that it is
4 premised on a legal conclusion, overbroad, vague and ambiguous.
