On July 23, 2008 this Court entered an order admitting numerous deposition designations into the record. *See* Dkt. Entry No. 1014. The deposition designations of Georgia Morrison-Flores, Gerri Ratliff and Michael Quinn were not among them. Gonzalez Plaintiffs believe the Court admitted the designations of the three deponents earlier in the case and now seek clarification that the designations are in the record.

On July 8, 2008 Gonzalez Plaintiffs filed their Motion to Admit Depositions and Declaration Testimony at Trial, which sought the admission of the deposition designations and declarations of Ms. Morrison-Flores and the deposition designations of Ms. Ratliff and Mr. Quinn. *See* Dkt. Entry No. 929. On July 9, 2008 this Court issued an order that granted the Motion to Admit except as to a Morrison-Flores declaration, which the Court ruled would not enter the record. *See* Dkt. Entry No. 937. After the Court's July 9, 2008 order Gonzalez Plaintiffs understood that the three deposition designations were admitted. Gonzalez Plaintiffs now respectfully seek clarification from the Court that the deposition designations of Georgia Morrison-Flores, Gerri Ratliff and Michael Quinn are a part of the record in this case.
