1 The Court has considered the Motion to Strike Portions of Gonzalez Plaintiffs'
2 Factual Submission in Response to Motion for Summary Judgment by Defendants State
3 of Arizona and Arizona Secretary of State (collectively, "State Defendants"). The Court
4 also has considered the response of the Gonzalez Plaintiffs, and the State Defendants'
5 reply in support of their motion.

6 The Court finds good cause to grant the motion.

7 IT IS ORDERED therefore granting the State Defendants' Motion to Strike
