16 For the purposes of trial, the Parties agree not to dispute the authenticity,
17 foundation or hearsay, insofar as a County Defendant would be able to testify to the
18 same. This stipulation applies to Gonzalez Plaintiffs’ Trial Exhibits 8, 123, 226, 241,
19 248, 251, 252, 253, 278, 317, 318, 319, 320, 321, 404, 405, 442, 443, 444, 445, 446,
20 447, 450, 451, 452, 453, 454, 600-616, 620-627, 645-647, 723, 724, 761-763.

21 These exhibits relate to Coconino County. Previously, Coconino County entered into a
22 stipulation (Doc. 902) regarding the admissibility of Gonzalez Plaintiffs’ Trial Exhibits

1 that were produced by Coconino County. The State and Twelve County Defendants
2 objected to this stipulation and maintain their objection. The parties do not waive other
3 objections, such as hearsay within hearsay, which the testimony of a County Defendant
4 could not remedy. Such objections are expressly reserved for trial.

5 The parties further stipulate that if the above-referenced documents are deemed
6 by the Court to be authentic, have proper foundation and not contain hearsay, the
7 testimony of the Coconino County Defendants is not needed at trial and Gonzalez
8 Plaintiffs voluntarily withdraw the subpoenas of these officials.
