**DECLARATION OF SARAH NOLAN**

SARAH NOLAN declares pursuant to 28 U.S.C. § 1746:

1. I am an associate with the law firm of Paul, Weiss, Rifkind, Wharton & Garrison, LLP, and am counsel for the Plaintiffs AFL-CIO, SEIU, AFSCME International, AFSCME Council 79, and Emma Yaiza Diaz in this case. I submit this declaration in support of Plaintiffs' Opposition to Summary Judgment.

2. The purpose of this declaration is to explain the methods used to calculate data related to incomplete voter registrations submitted during the weeks immediately prior to the 2004 and 2006 general elections throughout the state of Florida and in Miami-Dade, Broward, Duval, Palm Beach and Orange Counties ("the Five Counties").

3. The Secretary of State produced electronic data purporting to contain information related to incomplete applications. The Secretary provided a written explanation accompanying the data, titled Data Table Information, a true and correct copy of which is attached as Exhibit A.

4. The electronic file "diaz\_inc\_data" produced by the Secretary purports to contain "records of all incomplete applications recorded in the Florida Voter

Registration System (FVRS) from January 1, 2006 through June 22, 2007.” (Ex. 1 at 1.) The file includes fields that purport to contain each applicant’s voter ID, name, address, county of residence, registration date, and race. This file was converted to Excel format by Paul, Weiss’s technical support staff under my supervision. The file was sorted to identify all records in which the “registration date” was between Sept. 11, 2006 and Oct. 10, 2006. Where duplicate records for a voter ID number were identified, only one record per voter ID number was counted. The results showed 11,752 records with unique voter IDs had a registration date between Sept. 11, 2006 and Oct. 10, 2006. The data was then sorted by county of residence. The results were that 1,288 records were identified with Broward County (BRO), 2,633 records with Miami-Dade County (DAD), 263 records with Duval County (DUV), 1,364 with Orange County (ORA) and 1,364, 1,000 with Palm Beach County (PAL). The total number of records identified within these five counties was 6,548.

5. Miami-Dade County produced hard copies of incomplete voter registration applications bearing what were represented by Miami-Dade’s counsel to be date stamps of the date an application was received by the Supervisor’s office. Under my supervision, these applications were reviewed and sorted according to the date received as marked on the copy of the application itself. The results were that 1,514 of these incomplete voter registration applications were date-stamped between Sept. 11, 2006 and Oct. 10, 2006.

6. The review of the Miami Dade County applications discussed in paragraph 5 above further indicated that 3,052 of these applications were date-stamped between Sept. 5, 2004 and Oct. 4, 2004. A list of these applicants and the dates of their applications is attached as Exhibit B.

7. Miami-Dade County produced electronic pdf files labeled “Incomplete Notification Letters.” Each pdf file is labeled with a date and contains what counsel for Miami-Dade represented to be multiple notice letters addressed to voters. The pdf file labeled “10-10-2006” is 368 pages and contains 368 letters. The pdf file labeled “10-16-2006” is 594 pages and contains 594 letters.

8. Broward County produced a pdf file of images of notice letters that were sent to voters advising them that their application is incomplete. These letters were reviewed, sorted by date, and entered into an Excel chart under my supervision. The results show that 169 notices letters were dated Oct. 11, 2006 and 225 notice letters were dated Oct. 14, 2006. A list of the names on the notice letters and their respective dates is attached as Exhibit C.

9. Broward County produced a “search hold” list on October 18, 2004 in response to a public records request by co-counsel The Advancement Project for data on incomplete applications. The list purports to include information on voter names, “cert numbers”, addresses, and registration dates (“regdate”). Under my supervision, the data was converted to Excel by Paul, Weiss’s technical support staff and was sorted by registration date. From the fact that this “search hold” list was represented by Broward as including only incomplete applications, I infer that “registration date” stands for the date that the new application was first entered into the database. The results showed 1,508 records with a registration date between Sept. 5, 2004 and Oct. 4, 2004. A list of these results is attached as Exhibit D.

10. Palm Beach County produced hard copies of incomplete voter registration applications purported to be incomplete. These applications were reviewed and sorted by date under my supervision. The results show that 602 incomplete applications were date-stamped between Sept. 11, 2006 and Oct. 10, 2006.

11. The review of the Palm Beach County applications described above indicated that 538 applications were date-stamped between Sept. 5, 2004 and Oct. 4, 2004. A list of these applications is attached as Exhibit E.

12. Orange County produced an Excel file labeled “Spcl\_rqst\_MD\_072507” that purported to contain information on approximately 2,500 incomplete registrations received after January 1, 2006. The file purports to contain voter ID numbers, voter names, a “source date” and an “activity date” for each record. The “source date” purports to be the date the Orange County Supervisor of Elections received

the applications. The data was sorted by source date. The result was that 290 records had a source date between Sept. 11, 2006 and Oct. 10, 2006.

13. Orange County produced a file labeled "Voter-  
\_WO2906\_06\_01\_2007." The file purports to contain a list of voters who between Jan. 1, 2000 and Dec. 31, 2005 received an incomplete application letter. The file purports to contain information including voter names, addresses, and registration dates. The file was converted to Excel by Paul, Weiss's technical support staff under my supervision. The data was sorted by registration date. The result was that 394 records had a registration date between Sept. 5, 2004 and Oct. 4, 2004.

14. Duval County produced hard copies of incomplete voter registration applications. These applications were reviewed and sorted by date under my supervision. The results show that 235 applications were date-stamped between Sept. 11, 2006 to Oct. 10, 2006.

15. The review of the Duval County applications described in paragraph 14 indicated that 381 applications were date-stamped between Sept. 5, 2004 to Oct. 4, 2004.

16. The "fvrs\_notification\_to\_soes" file produced by the Secretary of State purports to contains "records of FVRS system notifications to the Supervisors of Elections related to data/application activities." The file has a column that purports to indicate the date a notification was sent from the FVRS system to the Supervisor of Election in the county associated with the application. The file has a column that purports to indicate what type of notification was sent. According to the Data Table Information, "NINC" indicates a notice of incomplete application, "NHMV" indicates a driver's license or social security number match error, "NAPP" indicates an acknowledgement of an application, and "NWFL" indicates "a work flow message requiring a document to be sent to a voter." The file also has a column that purports to indicate the "system error code." Attached as Exhibit F is a true and correct copy of the document explaining the system error codes produced by the Secretary in connection with this data. The codes provided include: "Incomplete: Citizen Box"," Incomplete:

Felon”, “Incomplete: Mental”, “Incomplete: DLN and SSN4 were both blank” and “Incomplete: Date of Birth”, and “Incomplete Address.”

17. The record associated with David Fleuriot’s (Voter ID: 114701226) application in the “fvrs\_notification\_to\_soes” indicates that a notice of incomplete application was sent to a supervisor on Oct. 5, 2006. The error codes associated with this notice were: “Incomplete: Citizen Box,” “Incomplete Felon”, “Incomplete Mental”, and “Incomplete: DLN and SSN4 were both blank.”

18. The record associated with Sergio Hrvatin’s (Voter ID: 114587840) application in the “fvrs\_notification\_to\_soes” file indicates that a notice of incomplete application was sent to a supervisor on August 25, 2006. The error codes associated with this notice were: “Incomplete: Date of Birth”, “Incomplete: Felon”, “Incomplete: Mental”, “Incomplete: Citizen Box.”

19. The records associated with Marie Olive Gayle Kirlew’s (Voter ID: 114574769) application in the “fvrs\_notification\_to\_soes” file indicates that a notice of incomplete application was sent to a supervisor on August 22, 2006. The error codes associated with this notice were: “Incomplete: Felon” and “Incomplete: Mental.” The file also indicates that another application was received from Ms. Gayle Kirlew on Sept. 1, 2006. Another notice of incomplete application was sent to a supervisor on Sept. 5, 2006. The error code associated with this notice was “Incomplete: social security number could not be verified as valid.” There is no record in the “diaz\_act\_voter\_data” file for Ms. Gayle Kirlew.

20. The “diaz\_inc\_data” file record for Patricia Ann Benvenuto (Voter ID: 114608551) indicates a registration date of August 28, 2006. The “fvrs\_notification\_to\_soes” indicates that a notice of incomplete application was sent to a supervisor on Sept. 25, 2006. There is no record in the “diaz\_act\_voter\_data” file for Ms. Benvenuto.

21. The file labeled “diaz\_act\_voter\_data” purports to contain “active voter records associated with some of the identification numbers (‘voter\_id’) that are

associated with incomplete applications.” (Ex. A at 3.) The term “active voter record” is not defined in the Data Table Information.

22. The data provided by the Secretary does not purport to contain information about a voter’s registration status that is not linked to that voter’s record(s) of incomplete application.

23. The data provided by the Secretary does not purport to include information about whether voters included in the data set actually voted.

24. The “diaz\_inc\_data” file was sorted to identify applications with a registration date between Aug. 8, 2006 and Oct. 8, 2006 in accordance with the methods described in paragraph 4. This data was then sorted to identify records in the Five Counties. A file including only the applications with a registration date between Aug. 8, 2006 and Oct. 8, 2006 from the Five Counties was sent to Elizabeth Westfall to send to the Plaintiffs for comparison with their membership lists. Due to a data conversion mistake that was detected too late in the discovery process to repair, only 65,535 records (of the 103,442) in the “diaz\_inc\_data” were sorted and delivered to the technical staff at the AFL-CIO and the SEIU for purposes of identifying injured union members through matching the data on incompletes against lists of union members. There is a reasonable likelihood that the number of injured union members provided on Schedule A was understated.

I declare under penalty of perjury that the foregoing is true and correct.

DATA TABLE INFORMATION

(Prepared in response to discovery requests in Diaz v. Browning)

**TABLES:** These tables cover the period from January 1, 2006 through June 22, 2007. Each one has been saved in a tab delimited file format with column headings. They contain data in active fields with the exception of the data protected under the public records law (social security numbers, last 4 digits of the social security number, driver's license number including the state identification number, the applicant or voter's registration source, absentee voter information, or address and telephone numbers for select high-risk professionals who have requested protection under the public records law (ss. 97.0585, s. 101.62(3), and s. 119.071(4)(d), F.S.))

**DIAZ INC DATA:** Contains records of all incomplete applications recorded in the Florida Voter Registration System (FVRS) from January 1, 2006 through June 22, 2007.

*Total number of records: 103442 (multiple records for individual voter ID)*

*Total number of active applications: 38844*

*Total number of closed applications: 64598*

*Total number of distinct voter ID numbers: 70471*

Applications submitted to FVRS for processing contains two flags, one field to indicate it is an applicant record ('voter\_app\_flag'), containing the code value of 'A' for 'Applicant'; and another field to indicate if the application is *active* or *closed* ('app\_active') containing a code value of 'A' for *active* applications or a 'C' for *closed* applications. Only one application can be active in the FVRS system, if a new application is received with the same identification number ('voter\_id'), the older application record will be closed and the new application will become the active record containing the new unique sequence number ('voter\_seq') which creates the unique key ('voter\_seq', 'voter\_id'). Once a new application successfully completes the eligibility process it becomes the active voter record, the code value for the 'voter\_app\_flag' is changed to a 'V' for 'Voter'; the 'app\_active' flag is not relevant to active voter records.

The race code values in the record are as follows:

- 1 *American Indian or Alaskan Native*
- 2 *Asian or Pacific Islander*
- 3 *Black, Not Hispanic*
- 4 *Hispanic*
- 5 *White, Not Hispanic*
- 6 *Other*
- 9 *Unknown*

DATA TABLE INFORMATION

(Prepared in response to discovery requests in Diaz v. Browning)

**DIAZ AUDIT MASTER**: Contains FVRS audit records for incoming transactions for related data applications. The code values for the registration transaction type field in this table are as follows:

*R = Registration Attempt*  
*C = Change Registration Details*  
*I = Incomplete Registration*  
*D = Denial*

*Total number of records: 363966 (multiple records for individual voter ID)*  
*Total number of distinct voter ID numbers: 70419*

**DIAZ FVRS NOTIFICATION TO SOES**: Contains records of FVRS system notifications to the Supervisors of Elections related to data/application activities. Some notifications may trigger the SOES' office to generate contact workflow (i.e. send applicant notice regarding voter registration status) to the applicant/voter; update local SOES database, or may just be informational for related data applications.

DATA TABLE INFORMATION

(Prepared in response to discovery requests in Diaz v. Browning)

**DIAZ ACT VOTER DATA**: Contains active voter records associated with some of the identifications numbers ('voter\_id') that are associated with incomplete applications. Once an application has become an active voter record, additional applications can be processed for changes that will then be applied to the active voter record, when the voter record has been updated the application record is closed. Active voter records are identified by a field named 'voter\_app\_flag' which contains the code value of 'V'. If an application is received for an active voter record and is incomplete, this **does not change** the voter's status of 'Active'. Also included are voter records that have been removed, are inactive, or pre-registered.

**DIAZ ADDR RES VM**: This is the residential address voter master table used to determine the current residential address record based on the most current effective date for applications and active voter records. Multiple address records can be stored for an application/voter record, the relevant data to associate the identification number ('voter\_id'), residential address record identifier ('address\_residential\_id'), and the effective date of the transaction are stored in this table to assist in generating the detailed residential address information from the residential address table.

*Total number of records: 50645 (multiple records for individual voter ID)*  
*Total number of distinct voter ID numbers: 31697*

**DIAZ ADDR RESID**: Contains detailed residential address information for applications and active voter records. Multiple address records can be stored for an identification number (voter\_id') but this table must be joined with the residential address voter master table to extract the current detailed record based on the voter identification number ('voter\_id'). The address residential table unique identifiers are the 'address\_residential\_id' and voter sequence number ('voter\_seq').

DATA TABLE INFORMATION

(Prepared in response to discovery requests in Diaz v. Browning)

**DIAZ\_ADDR\_VM**: This is the address voter master table used to determine the current mailing or prior address record based on the most current effective date for applications and active voter records. Multiple address records can be stored for an application/voter record, the relevant data to associate the identification number ('voter\_id'), address record identifier ('address\_id'), and the effective date of the transaction are stored in this table to assist in generating the detailed address information from the address table.

*Total number of distinct voter ID numbers: 6999*

**DIAZ\_ADDR**: Contains detailed mailing and prior address information for applications and active voter records. Multiple address records can be stored for an identification number (voter\_id) but this table must be joined with the address voter master table to extract the current detailed record based on the voter identification number ('voter\_id'). The address table unique identifiers are the 'address\_id' and voter sequence number ('voter\_seq').

**DIAZ\_FORM\_IMAGES**: Contains information to identify the form image for applications. Multiple images can be stored for a single identification number ('voter\_id') and the current images are identified by the most recent image date, sequence number for that identification number ('voter\_seq'), and delete flag. The delete flag allows image files that have been erroneously associated with a record to be removed. The actual image is stored in a separate table.

**DIAZ\_VOTER\_DATES**: This contains information related to changes in the voter registration status date. Multiple dates can be stored for an identification number ('voter\_id') and the current dates are identified by the most recent last update date, audit master identification number ('audit\_master\_id'), identification number ('voter\_id'), and delete flag. The delete flag allows files that have been erroneously associated with a record to be removed.
