22 The State of Arizona and Arizona Secretary of State Ken Bennett, through
23 undersigned counsel, move to continue the deadline for the parties to submit their joint
24 proposed form of judgment by one week from July 26, 2013 to August 2, 2013. Good
25 cause exists to grant the continuance. Undersigned counsel is, and has been, in trial out-
26 of-town and away from relevant case files from the subject case since Wednesday, July
27 24, 2013. Plaintiffs did not submit their proposed draft language to the Defendants until
28 approximately 4:00 p.m. on Thursday, July 25, 2013. The State and Secretary Bennett

1 have legitimate concerns with some of the proposed language but cannot currently draft
2 suggested modifications to Plaintiffs' draft in sufficient time to reach an agreement and
3 file it by the end of the day today. This motion is made in good faith and not for
4 purposes of delay. In addition, Plaintiffs and the other Defendants do not oppose this
5 request.

6 For these reasons, Defendants State of Arizona and Bennett respectfully ask this
7 Court to grant a one-week continuance of the deadline to submit the proposed form of
8 judgment by August, 2, 2013. A proposed form of order accompanies this Motion.
