**UNOPPOSED MOTION FOR  
EXTENSION OF TIME FOR

1 Plaintiffs The Inter Tribal Council of Arizona, Inc., et al. (the “ITCA Plaintiffs”)  
2 respectfully file this Unopposed Motion for Briefing Schedule for Attorneys’ Fees and  
3 Costs.

4 On July 8, 2013, the Gonzalez Plaintiffs filed their Unopposed Motion for  
5 Extension of Time for Briefing Schedule for Attorneys’ Fees and Costs (Dckt. 1106).

6 On July 10, 2013, the Court granted the motion (Dckt. 1107).

7 The ITCA Plaintiffs now seek the Court’s permission to follow the same briefing  
8 schedule for attorneys’ fees and costs as now applies to the Gonzalez Plaintiffs.

9 For the reasons set forth in the Gonzalez Plaintiffs’ motion, as well as in the  
10 interest of creating a consistent schedule for the briefing of attorneys’ fees and costs for  
11 all parties, ITCA Plaintiffs respectfully request the Court to set a briefing schedule  
12 wherein ITCA Plaintiffs have thirty (30) days after this Court’s entry of final judgment to  
13 file an initial motion for award of attorneys’ fees and costs and sixty (60) days from the  
14 entry of final judgment to file a memorandum of points and authorities in support of the  
15 motion and all supporting documentation. Opposing counsel would then have fifteen  
16 (15) days after service of the memorandum of points and authorities in support of the  
17 motion for award of attorneys’ fees and costs in which to file a responsive memorandum  
18 and ITCA Plaintiffs would have fourteen (14) days after service of the responsive  
19 memorandum to file a reply.
