

*A. Preliminaries/Confidentiality*

1. Introduction

***B. Persons whose registration applications were rejected:***

1. Is the applicant aware that his/her voter registration application on [*date*] was rejected by [*county*] because he/she did not provide the U.S. proof of citizenship required by Prop 200?

***C. Registered voters whose conditional provisional ballots were not counted because they did not provide identification required by Proposition 200:***

1. Is the voter aware that his/her conditional provisional in the [*election/date of election*] was not counted because he/she did not provide identification to the election officials?
2. Was the voter aware that he/she would have to provide additional identification to county election officials in order to have his/her ballot counted?
3. Does the voter have any of the documents sufficient to demonstrate identity for voting at the polling place? What effort would be required to obtain this proof of identity?
4. Did the voter attempt to provide the required identification to the county election officials after completing and casting the conditional provisional ballot [whether later in the day on election day or after election day]?
