**MOTION OF NAZIRITE RUBEN FLORES PEREZ TO INTERVENE
OR IN THE ALTERNATIVE,
TO APPEAR AS AMICUS FOR WRITTEN COMMENT**

Nazirite Ruben Flores Perez ("Nazirite Perez") files this Motion to Intervene or, in the alternative to appear and participate as an amicus.

Movant Nazirite Perez is a resident of Bexar County, Texas. Perez has been on the ballot for United States House of Representatives, District 23 (of Texas) and at other times has also been on the ballot for Railroad Commission of Texas. Perez has garnered over 110,000 votes from registered voters in an election. Nazirite Perez retains the option to run for Congressional office in the future

Movant Nazirite Perez is also a member of the Libertarian Party of Texas and was a delegate to the 2006 conventions to nominate candidates for the upcoming November, 2006 election. Nazirite Perez complains and objects to any plan that will reinstate all candidates before the primary to run in the November election; delegate Nazirite Perez and other delegates nominated a Libertarian Party candidate for U.S. House of Representatives, District 20; there SHOULD NOT be reinstated candidates because then there would be two Libertarian Party candidates running for U.S. Congressional District 20. and if so, Perez complains that would confuse the voters and Perez complains of unconstitutionality of any plan to so-call "reinstate" any primary candidates who have already "lost" nomination to the November, 2006 election. Perez complains that any plan to "reinstate" any primary candidates in some districts while not in others would violate the equal protection and due process of the Constitution. Perez complains any plan to "reinstate" any primary candidates would violate First Amendment rights, etc. of the electors who have already voted on "a single nominee" for the November 2006 election from their respective party.

Finally, Perez complains this entire case is INVALID because the "State of Texas" was never named as a defendant; therefore this case must be immediately dismissed.


AFFIRMATION
