**DECLARATION OF BRANDON A. JESSUP**

I, BRANDON A. JESSUP, being of legal age and sound mind, do hereby depose and state as follows:

1. My name is Brandon A. Jessup. I am over the age of 18. The facts to which I am testifying are based upon personal knowledge and are true and correct to the best of my knowledge, information, and belief.

2. I reside in Canton Township, Wayne County, Michigan, and am employed by Advancement Project, a national non-partisan, nonprofit civil rights and racial justice organization based in Washington, DC, as part of its Voter Protection Team. My job title is Michigan Local Voter Protection Advocate, and I have held that position since May 2008. My job responsibilities include working with community groups, election officials, and the attorneys in my office to identify potential barriers to voter registration and voting that may impact traditionally underrepresented groups such as people of color, low-income citizens,

and students and other young adults. Once identified, we attempt to resolve any barriers prior to Election Day.

3. One of the ways that we identify potential barriers to voting and voter registration is to review public records from previous elections. Over the past several months, one of my primary responsibilities has been to review and analyze public records data produced by the City of Detroit Department of Elections, relating to provisional ballots cast during the November 2006 general election. We requested copies of summary reports and lists detailing information on the number of provisional ballots cast, counted, and rejected, and we also requested copies of all of the "Four-Step Procedure" forms that provisional voters are required to complete prior to receiving a provisional "envelope" ballot.

4. Advancement Project's review of the data thus far leaves us with a serious concern that numerous election official errors, coupled with unnecessary barriers to voter registration, resulted in the over-issuance and high rejection of provisional ballots cast in the City of Detroit. We have been and intend to continue working with Detroit's election officials to resolve these concerns prior to Election Day.

5. Attached as Exhibit A to this Declaration is a partial list prepared by the City of Detroit of voters whose provisional "envelope" ballots were not counted in the November 2006 general election, along with a list of reason(s) why each ballot was rejected. (City officials have not yet produced a full list detailing the rejection reasons for all envelope ballots rejected during the 2006 general election.)

6. The list provided by the City of Detroit indicates that several voters' provisional "envelope" ballots were rejected in the 2006 general election because their registrations had been cancelled due to residency and/or because their voter identification cards had been returned. Attached as Exhibit B to this Declaration are approximately eight (8) of the Four-Step Procedure forms completed by provisional voters whose "envelope" ballots were rejected for such reasons. All of these voters are also listed on the list attached as Exhibit A.

7. Several of the "envelope" ballots cast in Detroit during the 2006 general election were rejected because the voter was "not registered" or for reasons that the City of Detroit "cannot determine." Although our review of the "Four-Step Procedure Forms" is not yet complete, we suspect that many of these voters may likewise have been rejected due to being cancelled from the Qualified Voter File due to a returned voter card.

I hereby declare under penalty of perjury, pursuant to the laws of the United States, that the foregoing information is true and correct to the best of my knowledge, information, and belief.
